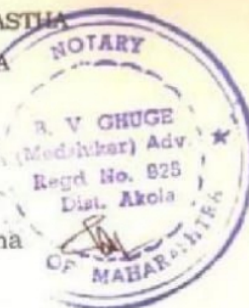

b) Life -Member :- Those who will pay 101/- (Five hundred one) or more than this amount such donor can become the life member of the institution and his membership shall be as a life member . Entry to Rs 51 /- will be changed separately .



11) FORMATIONS OF THE EXECUTIVE COMMITTEE OF THE INSTITUTIONS AND ITS CHAIR PERSON

12 .TENURE THE EXECUTIVE COMMITTEE AND PROCEDURE OF THE ELECTION

Term of the Executive Committee will be 5 (five) years . Every five years there will be election for Executive Committee . Executive Committee will be elected in general meeting by raising hands . If 2/3 ask for secret voting then will be secret voting .

13) CHAIR PERSON OF THE EXECUTIVE PERSONS AND THEIR FUNCTIONS

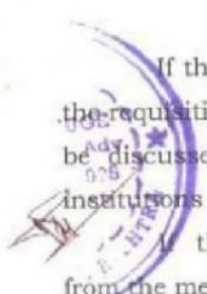

If the meeting is requisitioned by 2/3 of the members the President should call the requisitioned meeting within 08 days and the issue of "requisitioned meeting" will be discussed in the meeting and decision will be taken in the interest of the institutions.

If the requisitioned is not called by the President in that case two members from the members who requisitioned meeting should issue the notice with their signature out of them one will preside over the meeting as a chairman (President) and the resolution, decisions Executive Committee.

15) NOTICE OF EXECUTIVE COMMITTEE MEETING AND QUORUM .

Notice of the Executive Committee should be issued with the signature of the president through notice book or eventually by the part period 07 days meeting the members 2/3 majority of members is necessary on the day of meeting for want of 2/3 quorum of meeting will be postponed . Institutions can take the loan and deposits from the members . There will be no any interest on the such loan and deposits , all the amount will be without interest . When ever there will be need of loan to the institution it is necessary to take written permission from the capable office before taking loan .

22) PROVISION OF SALE AND PURCHASE OF IMMOVABLE PROPERTY

Any type of property can be purchased for the fulfillment of objective of the institutions . Except the resolution passed by permission of the capable office ,immovable property will not be sold .
