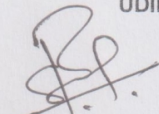
- Notes:- 1) The Society has accepted and repaid loan during the audit period in cash.

Those standards require that we plan and perform our audit to obtain reasonable assurance about whether the financial statements are free from material misstatement. An audit includes examining, on test check basis, evidence supporting the amounts and disclosures in the estimates made by the Society as well as evaluating the overall financial statement presentation. We believe that our audit provides a reasonable basis for our opinion.  
6) Some of the expenses are not supported with the vouchers.  
7) It is not possible to verify whether the receipts and payments said to have been made by an account payee or crossed cheques were actually so made as the necessary evidences are not in the possession of the Society.  
8) Bank reconciliation statements are not prepared by the Society.  
9) The society has not strictly followed accrual accounting system. Some of the expenses are accounted on cash basis.  
10) Quotations for the material purchases are not obtained by the Society.

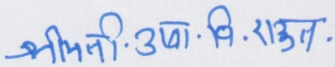

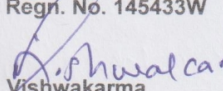

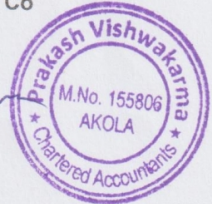
